




IAMLADP covers all aspects of language and conference service management. In recent years these have included:

IAMLADP

The overall objective of the International Annual Meeting on Language Arrangements, Documentation and Publications (IAMLADP) is to enhance the efficiency, quality and cost-effectiveness of conference, language and publishing services in international organizations.

IAMLADP began as an inter-agency meeting for conference-service managers at the United Nations. Current members include not only organizations in the UN system, but also European Union institutions, the OECD, the OSCE, the Economic Community of West African States and many other prominent international bodies.

With over 80 international organizations as members, IAMLADP has become **“the Davos for language and conference services”**

The United Nations Department for General Assembly and Conference Management (DGACM) in New York is the permanent Chair of IAMLADP. Activities are guided and coordinated between meetings by an Executive Committee and the IAMLADP secretariat, which is based at United Nations Headquarters in New York. The annual meetings are hosted by a member organization on a rotational basis.

The 2018 Annual Meeting, at ICAO headquarters in Montreal, brought together over

Topics and issues of common interest are addressed through working groups and task forces.

Currently there are IAMLADP task forces working on digital solutions, interpretation-specific matters, joint training ventures, e-learning, sustainable meetings, and the accessibility of meeting services, as well as a visiting linguist framework, a universities contact group and a subsidiary annual meeting on computer-assisted translation and terminology (JIAMCATT).



Knowledge-sharing, joint ventures and innovation

Over the years, IAMLADP has evolved not only as an instance for exploring issues and sharing ideas with counterparts in other organizations, but as a forum for pooling resources, establishing partnerships and embarking on joint ventures.

By bringing together conference service managers with diverse perspectives, experiences and areas of expertise, IAMLADP also serves as an effective peer-review mechanism that encourages creative thinking and innovation in the field. This has translated into fruitful cooperation in training, project development and the sharing of know-how and tools, as well as in the harmonization of policies and practices in key areas, to the benefit of IAMLADP organizations, their member States and stakeholders.
